1. Background

Junbesi is situated Dudhkunda Municipality ward no. 1 Solukhumbu District. It's at 3 hour walking distance from headquarter Salleri. Iding, Mopung, Pangkarma, Thupten Chholing, Sumjingma are nearest village from Junbesi. The altitude of Junbesi is 2700 meter from sea level. These areas are famous for natural beauty, Sherpa cultural tourism and hospitality.

Junbesi area was also affected by the earthquake of April 25, 2015 that killed more than 8,800 and injured more than 23,000 people of Nepal. More damage was created by the strong after sock that occurred in May 12, 2015.

Although the numbers of death in Junbesi area is null, we found major damages in the building of that area including school building, Monastery Building, Stupa and Mani Walls and 1 person have chest injured and is being treated at KPNM Health Center.

Due the cracks in the building, the houses are not seen safe and due to continuous numbers of after socks are repeating multiple number in a day, people can't dare to leave inside their houses and leaving outside under tents and tarpaulin.

Realizing these facts Kushudebu Public Health Mission Nepal decided to visit Junbesi area and support them. The advisor of Kushudebu Public Health Mission Nepal Mr. Ang Tshering Sherpa and his team had visited Junbeshi area. This report is prepared on the basis of that field visit to support the peoples.

2. Objectives

The objectives of prepare this report is:

- 1. To present the report of fact condition created by earthquake in Junbesi and its nearest village to Nepal government and Donner agencies.
- 2. To request Nepal government and Donner agencies for relief and support in rehabilitation and reconstruction of these area.

3. Activities:

The activities of site work are as follows.

3.1 Distribution of Non food relief item.



Due to disaster by the earth quake of 25th April, 2015 and repeated aftershocks, all people of Junbesi are living in temporary shelter. Schools had declared 37 days leave according to directions of government. People of the village have completely lost their confident and feeling

anxiety. Smiles have been lost from their faces. Realizing the sorrow of people KPHMN has distributed 24 tarpaulins, 4 roll of mattress, 16 Tent. Likewise KPHMN also started campaign of medical camp in different villages to treat the victims. The locals appreciated the relief work as the first ever relief they got after this disaster.







3.2 Distribution of food relief item.



In Mopung VDC, a victim family hadn't have any food for immediate livelihood, their house is fully damaged by earth quake and all of food items are buried under the destructed house so 60 kg of rice and NPR. 5000/- is provided for their regular and immediate livelihood. They will require continue support in future.

3.3 Mass meeting

The mass meeting was organized and coordinated by KPHMN in different villages in separate dates. The meeting was conducted on chairmanship of Mr. Ang Tshering Sherpa, advisor of KPHMN. In the mass meeting, the people from junbeshi and other village have requested to manage a





geologist to survey the condition of land in junbesi and other villagers as few land cracks are found on the hill side. They also requested to manage relief, rehabilitation and reconstruction of houses. The advisor and chairperson of KPHMN have appraised that the requests of community will refer to Donner agencies and request Donner agencies to support them.

The photocopy of minute is listed on annex 1 and photos are listed on annex 2.

3.4 Description of Damages

Among the 91 house hold reside in these area, 13 house hold are fully damaged, 78 house hold are partially damaged.

Among 3 schools (Junbesi secondary school, Fungboche School and Serlo School), all of them are fully damaged. They couldn't run in inside the buildings so Fungboche school have shifted to new location and remaining schools have setup tents and temporary class rooms of galvanized sheet for running their school temporarily.

Among the 7 monasteries, 3 monasteries (Serlo, Mopung, and Fungboche) are fully damaged, 3 monasteries (Sumjingma, Pangkarma, Thupten Chholing) are partially damaged and Junbeshi monastery is in fine condition.

The detail is listed on annex 3.

4. Immediate plan of KPHMN

As safety is the first parameter of being secure and villagers are also requesting for assuring the safety of the villager and village, the first priority will be requesting for the geologist for the proper survey of the village and hill side to assure whether the place is safe or not.

Rainy season of Nepal is going to start soon and tents and tarpaulin will not be feasible in monsoon. So the temporary shelter must be constructing before the starting the monsoon.

5. Condition of KPHMN Medical Center

The Building of KPHMN is also cracked. It can be repaired and maintained to run it daily activities, but there is a risk of stone fall down from hill. Currently the staffs are treating the patient in temporary camp and are staying temporary shelter.

As per the meeting with the local committee members and staffs of KPHMN, we got the suggestion of initiating a shifting process of the Medical center in new and safe location for better future of Medical center.

6. Budget

It is estimated that the total cost of completing the construction of temporary shelter is NPR 3,414,760.00. The estimation is done on the basis of distributing 3 bundles per each house hold, 7 bundles per each school and monastery,

It is estimated that per household 3 bundles, 7 bundles for school and monastery. So it is estimated that 301 bundles of galvanized sheet is required.

Detail are shown on annex 4

7. Recommendation

- 1. It would be better 1 household equal 1 shelter is provided.
- 2. Rainy season of Nepal is going to start soon. So the temporary shelter must be constructed before the starting the monsoon.
- 3. One family with 11 family members (husband, wife and their 7 sons, 2 daughters) from Mopung village having weak economical condition, the father is suffering from cancer and his treatment is ongoing at Kathmandu need financial support for the treatment.

8. Note

In Nepal the main responsibilities of rescue, relief, rehabilitation and reconstruction are Ministry of Home Affairs. There are many donor agencies, I/NGOs are want to support the victim from earth quake but Government wants to do all of these activities by one door system under government. If any donor agencies, I/NGOs want to help and re-built need to follow the below rules and regulation which are decided by government of Nepal on dated 2nd June 2015.

- 1. Compulsory agreement between KPHMN and government
- 2. To start to work within one week from agreement date
- 3. after completed the project hand over to government
- 4. Need to keep all the record of expenses of the project and audit.

So it is very important that KPHMN need to coordinate with the Nepal governments.
